1) Opening.

The Prince opened the meeting and expressed, on behalf of the members of the Steering Committee, his great appreciation for Mr. Getchell's summary of the Saltsjöbaden Conference. He congratulated Mr. Kohnstamm on his forthcoming appointment as President of the European University in Florence.

Mr. van der Beugel, who had been in Megève, informed the meeting that the arrangements for the next Conference seemed perfect in every respect.

2) Austrian participation in the Steering Committee.

Mr. Umbricht had suggested several times to invite an Austrian to be member of the Steering Committee.

It was suggested that Dr. Hans Igler, partner of Schoeller & Co. in Vienna, would be a good candidate, a suggestion which was supported by several members of the Steering Committee who were well acquainted with Dr. Igler.

Dr. Igler has great international experience and excellent relations, both with the public as well as with the private sector in Austria.

The Prince will invite Dr. Igler to become a member of the Steering Committee.

3) Agenda for the Conference and discussion on persons who should be approached to write introductory papers.

There was a consensus in the meeting that the subject should cover the state of affairs in the Atlantic World.

After a prolonged discussion, agreement was reached on the two following subjects:

- I Inflation: its political, social and economic implications in the context of changing priorities in the Atlantic World.
- II The prospects for the Atlantic World as seen from:
 - a) France; b) The Federal Republic of Germany;
 - c) The United Kingdom; d) The United States.

For the first subject, the names were mentioned of Mr. Aubrey Jones and Professor J. Kenneth Galbraith, Mr. Gabriel Hauge and Mr. Andrew Shonfield.

A first effort will be made to invite Mr. Jones and Prof. Galbraith. To this end, Sir Frederic Bennett will, as soon as possible, approach Mr. Jones, and inform the Secretariat accordingly.

After that, Mr. Johnson will approach Professor Galbraith and will inform the Secretariat.

As to the four papers on the second subject, for France

Baron de Rothschild will, after consultation with Mr. Baumgartner

approach Mr. André Fontaine of "Le Monde" and will inform the

Secretariat about the results.

The German members of the Steering Committee will approach Dr. Karl Kaiser.

For the United Kingdom, Sir Frederic Bennett will approach Mr. Roy Jenkins or Sir Denis Greenhill.

For the United States a provisional list of possible authors was discussed, notably:

Mr. Nicholas Katzenbach, Mr. James Chace, Mr. Adrian Fisher,

Mr. Graham Allison, Mr. Cyrus Vance, Mr. Andrew Pierre and

Mr. Marshall D. Shulman.

It will be left to the American members of the Steering Committee to make the definitive choice.

The importance was stressed that the European authors would not exclusively deal with their national point of view, but should bring the role of the European Communities into their papers.

- A rough outline of the working papers should be available at the Steering Committee meeting of January 6th, 1974.

 Papers should not exceed 15 pages and should be available at the Secretariat not later than March 1st, 1974.
- 5) A provisional geographical break-down of the number of participants was agreed upon:

Belgium Canada Denmark Finland France Germany Iceland International Italy Netherlands Norway Sweden Switzerland Turkey 7 (+1 if there are two authors of British United Kingdom working papers) 20-22 United States Austria

- 6) It would be extremely helpful if a first suggestion for hames of participants could be sent to the Secretariat by members of the Steering Committee in the first half of December.

 Members of the Steering Committee are free to approach already now those possible participants whose schedule requires an early warning.
- 7) The next meeting of the Steering Committee will take place at Soestdijk Palace on January 6th, 1974 at 10.30 a.m.

Dear Ernst,

I promised to let you have some brief remarks on the topic for the next Bilderberg Meeting, particularly in view of my unavoidable absence from the Steering Committee on the 14th.

I confess to some hesitation about your suggested title. I recognise, of course, that it has the great advantage that almost anything can be discussed under that heading and, given the fact that things are developing very fast, both in the economic and political sphere, it may be an advantage to be able to shift the emphasis at relatively short notice.

On the other hand it seems to me that to go on taking the pulse of the "Atlantic Community" would possibly encourage a very introverted, not to say hypochondriacal attitude on the part of the older members and boredom on the part of the younger ones. I think we have reached a stage where the analogy of the famous "special relationship" between Britain and the United States is not altogether out of place. The Atlantic Community exists - as I happen to believe that the "special relationship" still exists - but they are both constantly changing and they both have this in common that they are the stronger the less they are talked about.

Of all the suggestions I have seen, I think Gianni Agnelli's letter is most to the point. I rather like the idea of examining what "great power" (and perhaps also "super power") means nowadays in quite specific detail, and with special reference to

the relations between the United States and Europe, distinguishing carefully between: (a) narrower strategic and defence aspects; (b) wider foreign policy aspects; and (c) economic, that is to say trade and financial, relationships. I am sure we shall find that the power relationships (i. e. the mutual dependence of European countries on each other and on the United States and vice-versa) vary greatly under each of these headings.

I do not know whether these few thoughts will be of assistance, but if I had been able to be there on the 14th, I would have wished to amplify them.

Dear Ernst,

Since my return to town after the summer break, I have given some thought to your memorandum of August 18, with a view to defining two topics for the Megève meeting.

On the political plane, two possibles might be: a) the problem of political equilibrium in the Mediterranean area; and on a more general level, b) the evolution of the concept of a "great power", with the various implications for the definition of a new balance of power between the U.S.A., Europe, and other powers and blocks.

I feel that these are both topics of vital interest not only for Europeans, but also for Americans; and above all, they are not narrowly linked to situations which might conceivably be solved by next Spring.

On a more complex level, taking into consideration economic and social aspects, these are two wide-reaching topics which are of particular importance for the industrialized nations of the West:

- a) the formulation of a social policy which takes into account all the problems of economic reconstruction in the various countries, as required by current trade negotiations;
- b) economic cooperation with the countries of the East and with developing countries.

I hope that these suggestions may prove of some use at our meeting on October 14: I am not yet sure whether I shall be able to attend, but will let you know as soon as possible.

As I told Mrs. Le Roy in a telephone conversation this morning I have first an apology to make in that although admittedly I only received your letter of August 18th. at the beginning of September, on my return from a global political tour, you have not yet received any reply from me. In fact I did dictate a response immediately, but unfortunately to an unreliable standin, in my own secretary's absence; the former has now disappeared and I can nowhere find a copy of the letter 1 wrote, or be sure whether the original was already sent to you, signed on my behalf as I did authorise the girl to do. Be that as it may; I now anyway reply to you more usefully in the light of your latest memorandum, which has not yet come into my hands, but which was read out to me over the phone this morning.

To save a long response may I say that I quite agree with your tentative conclusions, although I hope that, in accordance with our usual practice, we shall not try to combine in a single debate economic problems, such as inflation and currency fluctuations, with our political theme. This does not mean that we can isolate one from the other, but it does mean that we should not seek to combine them too closely in our actual discussions.

There is one aspect of your suggested main title, "The State of the Atlantic Community - An Appraisal and Priorities", which I do feel ought to be included if the discussion is to be a real one. there is no need at all either to praise or criticise the Americans for their military withdrawal from the mainland of S.E. Asia, but it is idle to pretend that this withdrawal has not had psychological reactions of a negative type both in Europe and in the U.S.A. I have always believed, and events have proved this true, that "bring the boys home", can not be a geographical slogan limited to one part of the world. In Europe I have found many in recent months, of various nationalities, who privately if not publically, are wondering whether, if the heat got too great, there might not be a similar withdrawal from here. If these apprehensions led to a decision to increase European unity and defence capability to offset any reduction in their American shield, well and good; but the opposite seems to be the case in that there is a growing tendency to put unjustified, increasing faith in a detente providing the answer to trends in America, without any evidence at all to support the idea that Russian interest in establishing a hegemony throughout Europe has lapsed at all.

Although I appreciate that Australia and New Zealand are outside the Atlantic Area as such, there is no doubt that similar dangerous tendencies are evident there. Since they can no longer rely on American protection they do not instead want to do more to fend for themselves, but behave as if the best course open to them is again to pretend that the Communist powers no longer present any threat to them. Trends within Australia and New Zealand, and elsewhere in the South Pacific, are undoubtedly having their repercussions nearer to us here at home, and I do not think that, leaving Japan right out of it at the moment, we can afford to ignore the Australian parallel example of the sort of developments I have been outlining. Do you not think that there might be a case for considering a limited Australian participation again, as was so successfully done once before?

Looking forward to seeing you again on the evening of Saturday 13th., when I understand you are once more generously to provide a pre-meeting dinner party at the Amstel.

Agenda for Megève Meeting 1974

I understand very well the problem. Considering that the meeting is more than half a year ahead, it is difficult to strike a subject which comes into focus at the time of the meeting. We have, however, been lucky so far, especially last time with the energy crisis.

I believe we may have a similar chance again this year with a foreign exchange item and/or the future rate of interest levels. This will be guided by the varying inflation in the various countries. The question is: will the consciousness of the permanence of the inflation together with a smaller propensity to save lead to a higher interest level for good? Will the lender of a one year loan, for instance, take into consideration that the money he gets back, is at least 5% less worth? If this is so, it will make fixed exchange rates nearly impossible with variety of inflations in the various countries.

These problems will be dealt with, but by no means settled, by international meetings shortly, and I should think this is also a subject which would especially interest the French, Giscard D'Estaing anyway. Even if we have not before met a host nation wish about the subject for discussion, I think it is probably right to do it towards the French. We did so in Cannes, I think.

It will be difficult to pick a subject for next year's Bilderberg. The reason for this is that one sees a real crisis of moral leadership and authority in the West - in Europe hardly less than in America. This itself is too wide a subject to take on and is anyway inappropriate; but the trouble is that anything else will seem to have a comparatively pale appearance.

One aspect of Western disarray which might have the advantage - so dear to us in Bilderberg - of seeming to deal with something specific while allowing us to talk about anything we like, might be the question of global inflation. It is anyway probably time for us to pick up an economic subject. But apart from that, there appears to be much evidence that inflation - in almost all countries in the West - has now reached a point where it is practically out of control by democratic governments. It certainly is not responding to conventional correctives. Prices and incomes policies have, generally speaking, been disastrous failures. Moreover, the co-existence of unemployment and inflation is a phenomenon of fairly recent origin and has a paralytic effect on governments.

The effect of an inflation which has continued and grown over many years - even generations - would allow some examination of its implications for moral values generally, what the extent of government intervention ought to be, and, more specifically, whether a higher degree still of government control - e.g. over prices, wages and investment - is reconcilable with traditional Western freedom of the individual.

Dear Irmst

Some days ago I met Mr. Androsch at Alpbach and he apologized again that he was not able to participate in the last Bilderberg Conference. He explicitly asked for getting an invitation for the forthcoming Conference at Megève as early as possible in order to take note of the date.

I am sure that he expressed this desire in agreement with the Chancellor, and who knows the Austrian scene as well as I do must say that from the governing party either Mr. Androsch or Mr. Gratz, the present Mayor of Vienna, who is out of question because of his new function as Mayor, are adequate participants for Bilderberg.

It is already more difficult to name a member of the ÖVP because nobody of its present management is involved in international problems after Mr. Toncic is not available any longer.

I thought it useful to tell you these ideas already now so that we can adapt to the situation until our next meeting.

Coming now to your letter of August 18, 1973, I agree with you that the relations between the United States and Western Europe are in a difficult phase. There has been no conference more adequate to come back to

the original idea for installing the Bilderberg Conferences than the forthcoming meeting in Megève, e.g. to discuss the controversies between America and Western Europe where they are existing. At present we have to face them in almost all the areas, i.e. problems in connection with the Conferences in Tokyo and in Nairobi or problems in connection with the political and military presence of the United States in Europe.

But if, for instance, we put the monetary problem on the agenda we must avoid that the discussions become too academic and are led only by the monetary experts. Another point is that almost all the monetary experts or those who pretend to be were not right in their predictions of the development. What I would like to suggest is to discuss the economic problems on the background of foreign affairs.

I am quite sure that this complex of questions will meet the French interests in a way that we don't have to seek for a topic of particular interest to our French hosts. Let me quote one example from the economic field: Do have the trade problems priority over the monetary problems or vice versa? The French thesis obviously gives predominance to the monetary problems. Only this topic, I think, will arouse a vivid discussion.

Please don't worry that I pointed out my ideas such briefly, but I hope that they will be of some help to you.

1) I refer to the note Joe and I circulated on August 18th about subjects for the Megève Meeting in April 1974.

2) In the meantime we have received several proposals which have been circulated to you, or will be received by you before the October 14th meeting.

- 3) On October 14th we should discuss a possible Austrian membership of the Steering Committee, but the rest of our time can completely be devoted to the issue of the subject for the Megève Meeting.
- 4) Joe and I have seen each other in Germany last weekend, and we came to the conclusion that it is rather difficult for us to be very precise as to our suggestions for the Agenda in Megève.
- 5) We think, however, that it might be useful to give you our very preliminary thoughts.
- 6) It seems to us that looking at Bilderberg's purpose, we should deal in Megève with the relation between North America and Western Europe, which finds itself to say the least in the most complicated phase since the end of World War II.

- 7) It is of course true that this relationship is discussed in so many organizations, that it will be very hard to be "original".
- 8) On the other hand, we should recognize that Bilderberg should not necessarily aim at being original in its Agenda items, but at being original in the way we discuss these problems, prepare and organize our Meeting, and invite the right participants.
- 9) A very important question is of course that we should be more concrete than just discussing the set of relations between Europe and North America. This relation is so complicated at the present moment, that the question of priorities is a very real one.
- 10) Our suggestion therefore is that at our meeting of October 14th we explore the possibility of finding suitable topics in the framework of a general Agenda item, which might be described as:

"The State of the Atlantic Community: an Appraisal and Priorities".

- 11) A few additional comments:
 - a) Atlantic Community is not meant to be a political notion.

 It just means North America and Western Europe. Any
 other definition will do.

- b) We should certainly be very much aware of the fact that the problems are not at all exclusively American-European, but also very much intra-European.
- c) We should, in making the Agenda items more concrete, be very keen on a choice which is of interest to our French friends.
- d) Discussing an appraisal and priorities of the Atlantic Community does not exclude at all, for instance, a discussion on inflation.
- 12) Joe has not seen this note. The American members of the Steering Committee meet on October 2nd, in preparation for the October 14th meeting at Soestdijk Palace.
