Section 1 > Introduction

Purpose

The purpose of the Nevada State Homeland Security Strategy (SHSS) is to identify and address statewide priorities to achieve and sustain a strengthened ability to prevent, detect, deter, mitigate against, prepare for, respond to and recover from any natural, manmade and/or technological emergency or disaster up to and including any act of terrorism. The State, through implementation of this strategy, is seeking outcomes that will ensure a safe and secure Nevada through enhanced capabilities in intelligence, surveillance, rapid first response and recovery, the protection of critical infrastructure, and to promote public education and awareness.

Vision

The SHSS provides a framework for a safe and secure environment for the protection of Nevada residents and visitors; identifies mechanisms to maintain and enhance the critical infrastructure required to support and serve residents and visitors; and identifies objectives that build sufficient capacity to share those services with our neighboring states through continued leveraging of resources to ensure both statewide and region-wide capabilities.

Focus

Nevada continues to be one of the fastest growing states in the nation and depends heavily upon the tourism industry to support the State's economy. The majority of the world's largest resorts are located in Nevada, the tourism sector provides the largest employment base, and more than 50 million visitors pass through the state's major airports annually. Tourism provides a multi-billion dollar funding stream to the state that is used to fund schools and other public facilities, critical infrastructure, and public safety. More than 70% of the state's population, and 70% of the revenue derived from this industry, comes from southern Nevada. Therefore, it is critical that a large focus of the SHSS focus on increased communication and coordination, establishing and maintaining alignment between federal, tribal, state, and local goals, objectives, and initiatives, and leveraging resources among federal, state, tribal and local agencies, non-profit organizations, and volunteer groups. More specifically, Nevada's focus for the next three years will include, but is not limited to:

- 1) Measures in prevention through improved sharing of intelligence information and surveillance;

- 2) Communications Interoperability;
- 3) Development, review, and/or update of state and local emergency operations plans, continuity of government plans and terrorism prevention and detection plans while ensuring complete implementation of the National Incident Management System;
- 4) Development, review, and/or update of statewide interstate and intrastate mutual aid compacts, regional plans and regional collaboration;
- 5) Continued equipping and training of Nevada's emergency first responders and support agencies;
- 6) Establishing/enhancing agro-terrorism preparedness capabilities;
- 7) Improving Nevada's capabilities to detect, identify, and report radiological and nuclear materials present in unauthorized locations;
- 8) Public education and awareness programs;
- 9) Enhancing measures to secure and harden critical infrastructure sites;
- 10) Development and implementation of systems to secure and coordinate transportation resources;
- 11) Development, review, update and/or finalization of medical facility emergency care plans, and medical surge and mass prophylaxis capabilities;
- 12) Establish programs to serve special needs populations; and
- 13) To create an awareness of the legal issues that surround emergency management, emergency response and homeland security activities.

Through these initiatives, Nevada will continue to build and enhance a comprehensive and coordinated statewide and regional partnership of all agencies, preparing them to adequately respond to any type of emergency or disaster.

Coordination

The Governor of the state of Nevada designated the Nevada Department of Public Safety, Division of Emergency Management (DEM) as the State Administrative Agency (SAA) for this program. The DEM serves as the State's single point of contact relative to the administration of the Homeland Security Grant Program (HSGP), other emergency preparedness programs and all disaster assistance programs. Additionally, the Governor appointed a Homeland Security Advisor in November 2002. During the 2003 Legislative Session, legislation was passed creating Nevada's Commission on Homeland Security, whose oversight responsibilities include; review of policies, making recommendations to state and local agencies, oversight of preparedness funding to meet statewide goals, and advising the Governor on Homeland Security issues. During the 2005 Legislative Session, the Office of Homeland Security (OHS) was created and the Homeland Security Director acts as the State's single point of contact with the U.S. Department of Homeland Security (DHS) relative to sharing of sensitive information/intelligence. Duties inherent in that office include: advising the Governor on Homeland Security related matters, occupying a seat on the Homeland Security Commission, responding to DHS data specific requests and collaborating with federal, state and local jurisdictions relative to information/intelligence sharing and critical infrastructure protection measures and programs and citizen preparedness initiatives. Select members of the Commission and first responder communities (the SAA Working Group) established Nevada's homeland security goals and

objectives. This information was incorporated into the SHSS and the completed SHSS was then submitted to the Nevada Commission on Homeland Security for final review and approval. Subsequent revisions to this strategy are made through the collective efforts of the now existing Homeland Security Working Group consisting of statewide and Urban Area multi-jurisdiction and multi-discipline representatives. All revisions are submitted to the Commission for final review and approval.

Effort

To ensure coordination of the strategy development and the risk, vulnerability and needs assessments, members of the DEM, OHS and local government officials attended a regional workshop in San Francisco, CA where an overview of the SHSS and assessment program was presented. In addition to the workshop, training was provided to all local governments and attending tribal nations at the semi-annual Nevada Emergency Management Director's Conference. During this training, each county (defined as a jurisdiction) and tribal nation present was instructed to develop a working group that would consist of multi-jurisdictional and multi-discipline representation and how to complete the assessments through use of the Department of Justice/Office of Domestic Preparedness (DOJ/ODP) program. Subsequent to the conference, DEM staff contacted local governments and tribal nations not present to provide instruction and technical assistance to all jurisdictions and tribal nations throughout the process. This strategy is a result of all of those collaborative efforts. The evolution of this strategy has resulted from the changes and new mandates imposed by the federal government, the statewide progression in achieving preparedness milestones and subsequent identification of additional capability needs.

Description of Jurisdictions

In 1999, the State of Nevada established the Weapons of Mass Destruction Steering Committee to provide guidance and direction to the state on all WMD related issues. At that time, the State surveyed the counties to determine what was perceived as the best approach in determining what a "jurisdiction" should be. It was unanimously decided by the counties, and approved by the State Administrative Agency, that the jurisdictions identified in the State for WMD/Homeland Security would follow the State's current county jurisdictional lines. It was further decided that it would be best to utilize the existing Local Emergency Planning Committees' (LEPC's) structure as the conveyance for all WMD/Homeland Security issues. This determination was made based on the multi-jurisdictional/multi-discipline representation that is comprised within each LEPC. Additionally, a vast majority of the LEPC's within the state had already adopted an "all hazards" approach and could therefore utilize this existing body. Thus, 17 jurisdictions representing each of the 17 counties plus an additional jurisdiction representing the State's needs equates to 18 jurisdictions. It was further determined that each participating tribal nation will be treated similarly as an independent jurisdiction.

Description of Regions

The State of Nevada is not currently organized into regions. At this time, the State does not have any plans to regionalize due to the topography and unique diversity of its jurisdictions. However, where applicable, the State will work to regionalize preparedness capabilities. During regular day-to-day operations, our jurisdictions that border other state's jurisdictions provide mutual aid through pre-established agreements that are generally discipline specific (i.e., law enforcement, fire, EMS, etc.). In the event that our state or any other state is affected by a catastrophic disaster or emergency, the State of Nevada is a signatory member of the Emergency Management Assistance Compact (EMAC) for the purposes of participating in state-to-state mutual aid. Further, the State has developed and ratified an intra-state mutual aid agreement known as the Nevada Emergency Management Assistance Compact (NEMAC) that is intended to allow for the sharing of resources between its jurisdictions with similar provisions and protections as afforded state-to-state under EMAC. These mutual aid agreements are utilized in this State's efforts to respond to and recover from major events. Additionally, there are continuing efforts within the state in preparing for a major event that include planning, training, and exercise that are performed at the state level, within individual jurisdictions and sometimes include multi-jurisdictional efforts, when possible.

For the purpose of prevention and protection against major events, the State of Nevada has established a working group of intelligence analysts from every federal, state, and local agency that maintains an intelligence function. This working group will continue to operate until the fusion centers are fully operational at which time the efforts of the working group will be merged into the fusion centers in accordance with the Nevada Information and Intelligence Sharing Concept of Operations Plan. The sharing of intelligence clarifies data and provides each agency with a common intelligence picture. This type of collaboration is essential to the State's effectiveness in preventing, protecting and deterring acts of terrorism in Nevada.

Goal: Goal: Develop an intrastate, interstate and regional network for collection, sharing and analysis of surveillance and intelligence information.
(Prevention & Protection)

Objective Objective: Organization.
Develop the organizational structure for the sharing of intelligence data between federal, state, local and tribal public safety agencies by December, 2007.

National Priority: Strengthen Information Sharing and Collaboration Capabilities

Step: Identify and establish methods and timelines for plan implementation and review by March, 2007.

Step: Identify stakeholders and participants, and establish participant agreements by July, 2008.

- Step:** Develop a long term funding strategy, leveraging state and local funds, to financially sustain the counter-terrorism centers in the absence of federal funding by October, 2008.

Develop training syllabi and delivery schedules, to address the training and educational needs of each of the disciplines associated with information collection and intelligence production. Ongoing - Not date specific.

- Step:** Develop a cadre of trained instructors to ensure that training remains current and relevant to the mission, as well as providing sustainability in the absence of federal funding sources, by December, 2008.

Develop and implement exercises to determine if the counter-terrorism centers are operating effectively as designed, and within the

context of intra-state, regional and national information and intelligence sharing. Ongoing - Not date specific.

Step: Identify the essential functions necessary for the effective operation of counter-terrorism centers, and develop exercises to test the efficacy of these functions by December, 2008.

Step: Conduct exercises and prepare after action reports in compliance with the Homeland Security Exercise Evaluation Program (HSEEP). Note: Exercises may be conducted in conjunction with other goals and objectives outlined in this strategy. Ongoing - Not date specific.

Objective

Equip state and local agencies and emergency officials with the necessary equipment and facilities to establish counter-terrorism centers, and effectively collect, analyze and disseminate surveillance and intelligence data by December, 2008.

Step: Assess existing statewide equipment and system infrastructure by December, 2007.

Step: Determine necessary system enhancements and/or replacements by December, 2007.

Step: Establish procurement timelines for required equipment consistent with available funding by December, 2007.

Step: Facilitate equipment purchases to support and implement counter-terrorism centers by December, 2008.

Objective Objective: Organization.
Continue regular functioning of the Nevada Communication Steering Committee (NCSC) for the purpose of representing public safety communications interests of all levels of government (federal, state, county, city and tribal) and non-governmental organizations (NGOs), jurisdictions and public safety disciplines operating within the state. Ongoing - Not date specific.

National Priority: Strengthen Interoperable Communications Capabilities

Step: Assure effective NCSC functioning and broad representation through executive appointment and member commitment. Ongoing - Not date specific.

Step: Maintain the NCSC as a forum for discussion of any and all activities, proposals and initiatives pertaining to public safety communications interoperability within the state. Ongoing - not date specific.

Step: Determine direction, make decisions, set priorities and provide oversight of implementation efforts regarding public safety communications interoperability interests within the state. Ongoing - not date specific.

Step: Report progress on achieving this goal annually to the Nevada Commission on Homeland Security, not later than December 31st of each year.

Establish and maintain a statewide plan for communications interoperability, the Nevada State Communications Interoperability Plan (SCIP), by December, 2007 - Subsequently to be ongoing.

- Step:** Collect, assess and cross-reference the operational needs for communications interoperability. Ongoing - Not date specific.
- Step:** Collect information to inventory the facilities, quantities, locations and technical parameters of public safety communications equipment within the state. Ongoing - Not date specific.
- Step:** Identify specific equipment needs, required training and SOPs based on gap analysis. Ongoing - Not date specific.
- Step:** Establish standards for equipment/technology, training and operating procedures to be updated as necessary. Ongoing - Not date specific.
- Step:** Develop and facilitate agreements pertaining to communications interoperability procedures, usage, and operation and maintenance as necessary. Ongoing - Not date specific.
- Step:** Plan for and implement funding sources to include identification of funding sources to sustain and maintain statewide interoperable communications systems. Ongoing - Not date specific.

Develop and deliver training on the technical setup and operational use of communications interoperability assets to public safety communications users and technical support personnel. Ongoing - Not date specific.

- Step:** Determine training applicability, eligibility and certification need and criteria. Ongoing - Not date specific.

- Step:** Prepare after action reports to be completed within 60 days of an exercise as required by the Homeland Security Exercise Evaluation Program (HSEEP).

- Step:** Identify and consider provisions for equipment maintenance and sustainability. Ongoing - Not date specific.

Objective Objective: Organization.
Establish statewide working groups to insure ongoing response and support agency involvement in response planning, training and exercise activities. Ongoing - Not date specific.

National Priority: Strengthen CBRNE Detection, Response, & Decontamination Capabilities

Step: Establish a working group to facilitate the adoption of statewide training and credentialing standards for first responders and support personnel by December, 2007.

Step: Establish a working group to facilitate the development of two Nevada Type II Incident Management Teams (IMTs), one each in the northern and southern regions by December, 2007.

Objective Objective: Plans/Procedures.
Develop a comprehensive three-year training and exercise plan, revised annually, that will test and enhance the response capabilities of responders and support personnel statewide. Ongoing - Not date specific.

Step: Conduct annual Training and Exercise Planning Workshops (TEPWs) to develop a statewide plan that provides for training under an all-hazards methodology . Ongoing - Not date specific.

Step: Identify statewide training shortfalls through the annual Training and Exercise Planning Workshop (TEPW) process and through the various regional and discipline specific training working groups. Ongoing - Not date specific.

Step: Develop standardized, statewide baseline training requirements for emergency first responders, administrators, support agency officials, public health officials and elected/appointed officials by January, 2008, subsequently to be reevaluated annually.

Step: Create statewide training database to maintain training records of all emergency first responders and public safety personnel by December, 2008.

Step: Deliver or assist in the delivery of any required training as identified and as is permissible through available funding. Ongoing - Not date specific.

Coordinate the effective delivery of a comprehensive exercise program, compliant with the Homeland Security Exercise Evaluation Program (HSEEP), at the state, local and tribal government levels based on identified needs and as is permissible through available funding. Ongoing - Not date specific.

Step: Identify the statewide exercise program needs through the annual Training and Exercise Planning Workshop

Step: Provide HSEEP training statewide as needed to insure that all exercises are HSEEP compliant and that there are sufficient trained personnel resources within all levels of government to effectively maintain a comprehensive exercise program. Ongoing - Not date specific.

Step: Conduct identified exercise events in compliance with the HSEEP and as is permissible through available funding and provide technical exercise assistance as requested. Note: Exercises may be conducted in conjunction with other goals and objectives outlined in this strategy. Ongoing - Not date specific.

Establish equipment needs and continue to equip emergency first responders as is permissible through available federal, state, local and tribal funding. Ongoing - Not date specific.

Step: Establish working groups to perform equipment needs assessments and periodic reevaluations. Ongoing - Not date specific.
