## **UPDATE:** Continuing Series of White Powder Letters in New Jersey

(U//FOUO) NJ Regional Operations Intelligence Center (NJ ROIC) Threat Analysis Program ~ AE201003-204



(U//FOUO) The current series of "white powder" incidents with a New Jersey nexus now involves 25 mailings – the most recent targets being the Jersey City Municipal Court and Camden's City Hall. The mailings have gone to law enforcement (6), courts (6), banks (5), and other government offices (8). To date, the envelopes have tested negative for hazardous substances, and individuals exposed to the substances are asymptomatic. The map on the following page identifies where these incidents have occurred.<sup>2</sup>

(U//FOUO) As reported in previous NJ ROIC alerts and NJ Common Operating Picture reports, these incidents involve envelopes addressed with block print writing (pictured above<sup>5</sup>) that contain smaller envelopes labeled "white powder" or "swine flu." No suspects have been named, but this series appears similar to a previous string of incidents involving 11 letters in July 2009.<sup>6</sup>

(U//FOUO) The motive behind these mailings is unknown at this time – they could involve a prank, a grudge, a crime, pre-operational testing of the mail, or mental instability. In a recent, unrelated "white powder" case, FBI Newark described the hoax letters as a selfish act to instill fear in the recipient due to the perpetrator's inability to cope with his/her own personal issues.

(U//FOUO) The FBI Newark JTTF, in conjunction with other agencies, continues to investigate this case. The most recent letters are currently being analyzed and pending DNA testing by the FBI laboratory in Quantico, VA.<sup>9</sup>


